Two-Day Legal Awareness Programme (LAP)

In view to aware women about different laws and Acts, formulated to protect the rights of women, the Commission organizes tow-day legal awareness camp in different parts of Tripura, under sponsorship of National Commission for Women (NCW). In the year 2015-16 total nine (9) LAPs were organized. Among 9 LAPs Four (4) were organized for House Wives group, Four (4) were for adolescent and young girls of Colleges and University, and one(1) was for Working Women.
