

## RECOMMENDATIONS OF THE COMMISSION DURING THE YEAR 2012-2013

Following recommendations were sent by the Commission to concerned Departments of State Government during the period under report:

1. "Integrated policy for Women" may be formulated
2. 24-hours women help line may be introduced under each SP Offices in the State ;
3. Establishment of First track court and special court for speedy disposal of women related cases.
4. Self defence training may be arranged for girl child in schools and colleges ;
5. Introduction of women issues including Acts regarding protection of Girl Child and Women and Constitutional provision for women in High and Higher Secondary School syllabus and also in the syllabus of College and University level education.
6. Separate Court may be established for speedy disposal of the women related cases for providing relief to the victim;
7. Reservation of equal seat in Govt. transport system
8. Separate and independent officer may be appointed as Protection Officer;
9. At least one District Level Short-Stay Home in each district needs be established for providing immediate safe shelter to the victim of PWDV Act-2005 under the Department of Social Welfare and Social Education;
10. Copy of Court Order should be issued by the Magistrates to Protection Officers for follow up of the cases referred by them ;
11. Seminar/Workshop/Training Programme may be organised for all Stake Holder of PWDV Act-2005 by the concerned Department;
12. Mass Awareness Generation Programme on PWDV Act-2005 may be initiated;
13. District Level Counselling Centre with posting of designated Counsellor may be established under Deptt. of SW & SE.
14. All Sub-Divisional Courts may be declared as Court for implementing this Act until establishment of separate Court for this purpose.
15. Compulsory observance of following four(4) occasions through organizing Seminar, Discussions, Debate, and Essay Writing in every Govt. Degree Colleges in every year:-
  - (i) Women's Day on 8<sup>th</sup> March;
  - (ii) Anti-Dowry Week from 26<sup>th</sup> November to 2<sup>nd</sup> December;
  - (iii) National Girl-Child Day on 24<sup>th</sup> January;
  - (iv) World Mother's Day on 12<sup>th</sup> May;
16. Open Forum Discussion, Debate Competition, Workshop, Group Discussion, in Higher Secondary and Higher Education Institution are to be organised ;
17. Rules and Regulations regarding power and function of TCW may be formulated giving more power to TCW to curb crime against women in Tripura.
18. An initiative may be taken by the Government for including the statement of victims or the relatives of the victims for prime witness of the incident recorded by the Commission, through investigation under section 161 of IPC, so that the statements may not be manipulated by others.
19. Construction of new office building for TCW should be expedited as the Commission is facing difficulty to perform its duty in the existing.
20. Additional fund of Rs.11.00 lacs per annum should be provided to TCW.

21. Introduction and display of photo identity card in Bus, Auto and other light vehicles to identify the offender of crime against women in vehicle.
22. Appointment of female Judicial Magistrate for proceeding of women related cases;
23. Increase in posting of female police staff in each P.S.
24. Formation of Panchayat Level Committee for protection of girl child and women in each Panchayat with Panchayat members, Panchayat Secretary, Anganwari workers, Health Workers, Doctors of PHCs, ICDS Supervisors, O/C of local Ps and local Senior citizens. The function of the committee will be organizing monthly Awareness programme, keeping strict vigilance in concerned area to prevent inhuman behaviour against women and reporting incidents of domestic violence, atrocities against women, child marriage, witch hunting, dowry demand, wife beating, trafficking of women etc. to the concerned authority.
